

Heltwate School Covid 19 Catch-up Strategy 2020 -21 Nov 2020

What catch-up funding is for;

The government announced £1 billion of funding to support children and young people to catch up lost time after school closure. This is especially important for the most vulnerable and disadvantaged backgrounds.

Special schools will get £240 for each place for the 2020 to 2021 academic year.

Heltwate School Catch-up budget 2020 - 21 is £43,680

Payment schedule

Schools will get funding in 3 tranches.

- Autumn 2020 this is based on the latest available data on pupils in School.
- Spring 2021 based on updated pupil and place data. This payment will also take account of the initial part payment made in autumn 2020 so that schools will receive a total of £140 per place across the first 2 payment rounds.
- Summer 2021 term a further £100 per place.

To support schools to make the best use of this funding, the Education Endowment Foundation (EEF) has published a <u>coronavirus (COVID-19) support guide for</u> schools with evidence-based approaches to catch up for all students. This is reflected in the plan below.
